4. Fill in your information.
5. Upload a dated sales receipt for your lens purchase.
6. For SimplifEyes 1Day lenses, also upload an image of the detached product box end panels showing prescription information (one for each eye).
7. Click “SUBMIT” to finalize your rebate submission.
8. After we have verified with your Doctor that your lens fit was successful and the annual supply order was complete you will receive an email from [rebates@synergeyes.com](mailto:rebates@synergeyes.com) to the email address you provided containing a link to your Amazon eGift Card. Please allow 12-14 weeks for final fit verification and processing.
